# LAWN CARE AND LANDSCAPING

After a complete tour of the property by Howard DaCosta, our property manager, myself and Native Control, we noted quite a lot of browning lawns. Please make sure that your sprinkler's are working properly.

You may water two times a week up to 30 minutes per zone. For watering times, please check the sticker on you irrigation clock. If your lawn dies

and has to be replaced, the cost of replacement is the homeowner's responsibility, not the HOA or the Landscaper.

Due to the lack of rain we will be evaluating the lawn growth weekly. If there is no substantial growth by Friday we will call off the mowing for the following week. The lawns will then be moved every two weeks instead of weekly.

Any questions or complaints about lawn care, trimming or weeding, are to be directed to the Property Manager, not the landscape contractor or any of their employees. They have been instructed not to respond to you. They will only respond stating to please see your Property Manager. They have a job to do. Stopping them and asking questions only slows them

**down.** Besides, most of them don't speak English.

All complaint and work order forms must be filled out in person at the office or faxed to 772 878 6461. No work orders or complaints will be taken by telephone. We need a paper trail to make sure the work is getting done and the complaints are being resolved.

As most of you are aware, the Board of Directors at Lake Forest has settled our outstanding claim with Homes by Kennedy. The settlement came to just over \$157,000.00. Some of the money was placed in a short term CD we purchased for \$97,000.00.

No homes showed as being sold in the community during March. However, it appears that five homes will be closing in the near future, some of them having been foreclosed. These sales should help reduce some of the receivables from owners.

Financially we are still running at a small surplus due to unplanned revenue sources.



### **EMERGENCY CONTACT INFORMATION**

Late in 2006, the Florida Department of Highway Safety and Motor Vehicles (DHSMV) implemented a new emergency contact information system that allows Florida motorists to voluntarily provide emergency contact information online, using their Florida driver licenses or Florida identification cards. The information can then be accessed by law enforcement officers to notify designated contacts if a motorist is seriously injured or killed in a traffic crash.

After her daughter, Tiffany, was critically injured in a traffic crash in 2005, Christine Olson was not immediately notified of the incident because law enforcement officers working the crash had no emergency contact information. By the time Ms Olson was contacted, it was too late for her to say goodbye to her daughter. Ms Olson felt that some kind of system needed to be in place that would ensure the immediate contact of parents and loved ones in cases like this. She began a personal quest to make one available to all.

We are, once again, urging Florida motorists to go online and enter their emergency contact information. To date, over 743,000 Floridians have already done so. However, with over 18 million licensed

drivers and identification card holders in our state, many more need to take the time to go online and enter their information. Electra Bustle, Executive Director of DHSMV, encourages all Floridians to take a few moments and input this vital information, which, in the event of an unfortunate emergency, will make the information readily at hand, allowing law enforcement officials to quickly get in touch with those listed as a contact.

Anyone with a valid Florida driver license or identification card can go online and enter their emergency contact information at *www.flhsmv.gov*. The information is kept secure, and is used only by law enforcement officials in case of an emergency.

Please help us get the word out. It's easy to do, requires only a few minutes; and it's very important!

### IMPORTANT REMINDERS

Proceed up to the gate as it opens. Do not sit at the call box until the gate is fully open. By time you move, the gate will be closing. If any damage is done to the gate, you will be responsible to pay for repairs to the gate and your vehicle.

Extended parking at the clubhouse is by permit only. The vehicle(s) of any violators will be towed away at the owner's expense.

Care of the irrigation system is the homeowner's responsibility. It should be checked regularly. Homeowner's should check that their system is working properly. Many sprinklers are either broken, damaged or aimed to the street, not the lawn. This is a waste of our water supply.

Do not block sidewalks at driveways.

Parking is not permitted on the grass or sidewalks anywhere in the community.

Yard waste pick up is on Monday's. Yard waste is not to be put out for pick up until Sunday afternoon.

Maintenance fees are due January 1st, April 1st, July 1st and October 1st. Late fees and interest will be charged on the eleventh day after the due date. On the thirty first day after due date, you will be turned over to the attorney for collection. Attorney fees will be charged. If you have received a letter, you are already in violation
